Notification

Dated, Suri, the 07th Aug '2025

Whereas, A traffic restriction notification has already been imposed vide Memo No. 472(18)/MV dated 01.08.2025 for movement of Goods vehicle/Heavy goods vehicle/Buses whether loaded or empty over Tilpara Barrage Bridge (on NH-14) due to cracks & damages found at foundation level of the barrage on & from 01.08.2025 till the barrage bridge fully operational.

Now, in pursuance of the letter vide Memo No.837/Traffic dated. 07/08/2025 & the letter of Executive Engineer Mayurakshi Head Quarters Division, Suri, Birbhum vide his letter no 1381/1(2) dated 07.08.2025 to stop the movement of all kind of vehicles except pedestrian, bike & ambulance over Tilpara Barrage Bridge (on NH-14) due to sudden serious condition of the foundation of Tilpara Barrage.

Whereas, the safety of Tilpara Barrage Bridge and the surrounding infrastructure is of paramount importance, which connects the two banks of river Mayurakshi on road, it is essential to restrict traffic movement for structural integrity of the barrage and to ensure public safety as well.

Whereas, for this purpose traffic diversion of Kolkata / Burdwan / Asansol / Dubrajpur / Illambazar / Nalhati / Jangipur / Malda / Murshidabad bound goods vehicles & small vehicles be implemented immediately repeat immediately till the Tilpara Barrage Bridge become fully operational.

Now, therefore considering all aspects and in exercise of power conferred upon me under section 115 and section 116 of Motor Vehicles Act. 1988 and section 4(1) of West Bengal Traffic Regulation Act, 1965. I, Sri Bidhan Ray, W.B.C.S (Exe.), District Magistrate & Collector, Birbhum do hereby order that:-

9. Buses will not be allowed to ply on the bridge. Rather buses will be stationed at both sides of Tilpara Barrage Bridge for to and fro movement. North Bengal bound buses also have to take either of the diversion routes available for plying.
10. No Goods Vehicle/Heavy Goods Vehicle / Small Vehicle whether loaded or empty is allowed to ply on the bridge at any circumstances. Only Bike & Ambulance be allowed.
11. Executive Engineer Mayurakshi Head Quarters Division, suri, Birbhum is hereby requested to monitor the situation of the bridge by his technical teams on 24X7 basis and requested to make arrangement for Proper illumination at the bridge.
